Remind students that a case definition is a way to describe who has a health-related state by identifying what happened, where it happened and when it happened.

In this case the students are interested in teenage births that occurred to residents of Springfield, Massachusetts, during 2001.

Ask students if the mother was a teenager (15 –19 years old) when she gave birth. (Ask students to subtract the year of the mother's birth [1984] from the year of the child's birth [2001].
