Remind students that a case definition is a way to describe who has a health-related state by identifying what happened, where it happened and when it happened.

In this case the students are interested in teenage births that occurred to residents of Springfield, Massachusetts, during 2001.

Ask students if this child was born in 2001. (This child was born in 2001.)

Ask students if the mother was a teenager (15 –19 years old) when she gave birth. (Ask students to subtract the year of the mother's birth [1984] from the year of the child's birth [2001]. This mother was 17 years old when she gave birth. This mother was a teenager when she gave birth to this child.)

Ask students if this was a Springfield, Massachusetts, birth. (It is the location of the mother's residence, not the location of the hospital, that determines where the child was born. Even though this mother gave birth in a hospital in Holyoke, Massachusetts, this would still be a Springfield, Massachusetts, birth.)

Ask students if this is a Certificate of Live Birth for a baby born to a Springfield, Massachusetts, teenager during 2001.

Answer: Yes, but this may cause some confusion. When students subtract the year of the mother's birth (1981) from the year of the child's birth (2001), they will find 20 years' difference. However, the mother was born in October 1981 and her child was born in September 2001, making her 19 years old when her child was born.
